**Benjamin Moore Community Restoration Program announces grants and product donations to strengthen community and heritage groups across Canada**

**April 15, 2008** – What do the repainting of a drop-in centre for women and children, the conversion of a 1907 Post office for use as a community Arts Centre, the refurbishment of the premises of a Food Bank and the restoration of a heritage barn in a conservation area have in common? They are a few of this year’s 25 heritage and community project grant recipients for the **Benjamin Moore Community Restoration Program** in association with **Community Foundations of Canada (CFC)**.

“Our association with Community Foundations of Canada dates back to 1998,” says Richard Tremblay, General Manager Canadian Central & Eastern Markets, Benjamin Moore & Co., Limited. “Since then the Benjamin Moore Community Restoration Program has awarded 126 grants, totaling \$455,000 in financial assistance and an additional \$102,000 in donated paint and materials, to 74 different communities across Canada. In 2008 we once again opened up the program to qualifying organizations in the company’s Western, Central and Eastern Markets.”

This year, the Benjamin Moore Community Restoration Program’s \$100,000 donation enabled its partner Community Foundations of Canada (CFC) to extend grants to community groups in 14 communities across Canada. Grant recipients are located from Courtenay, BC in the West to Saint John, NB in the East.

“The Benjamin Moore Community Restoration Program provides selected charitable organizations with the materials and expertise necessary to refurbish buildings and facilities of historical interest or importance to their communities,” says Vincenza Travale, Chair of the Board of CFC. “This year’s continued commitment of \$100,000, which includes \$25,000 to support CFC’s national network of community foundations, enabled us to reach out to communities that we haven’t approached before.”

### **Four grants in Eastern Canada**

“The restoration program is enthusiastically supported by our Benjamin Moore Retailers,” says Richard Tremblay. “It enables them to make a positive difference in their communities by sharing something that we are passionate about – our expertise and our products – with people who are equally committed to the community and its heritage.”

A total of \$25,000 in financial support and \$5,000 in paint and materials has been given to community groups in Eastern Canada. In Saint John, NB the *Greater Saint John Hospice*, the *Centenary-Queen Square Care Centres* for children and adults, the *Saint John Community Loan Fund* and the *Saint John Arts Centre* all receive grants of cash and materials for renovation projects.

### **Applications for 2009 program**
